# Admission to RCI approved Diploma Level Courses through Centralized Online Admission Process for the Academic Session 2021-22

The NBER, RCI vide its Admission Notification No. 25-15/NBER(AIOAT)/RCI/2016 dated 12.10.2021 invited online applications from the prospective candidates for admission to D.Ed.Spl.Ed.(IDD), D.Ed.Spl.Ed.(HI), D.Ed.Spl.Ed.(VI), D.I.S.L.I., DTISL, D.Ed.Spl.Ed.(Db) , D.Ed.Spl.Ed.(CP) & D.Ed. Spl.Ed. (MD) Courses for the Academic Session 2021-22 through Centralized Online Admission Process 2021.

- 2. Based on the Online applications submitted by the prospective candidates, the Council has prepared the National List of eligible candidates for admission to aforesaid diploma level courses for admission to the eligible candidate(s) as per their choice of course and institutes in order to preference, subject to reporting to the concerned training institute to participate in the admission process. National list of eligible candidates is Annexed at A.
- 3. Candidates who have submitted their online applications successfully on or before the last date i.e. 11<sup>th</sup> November, 2021. However, they could not pay the online fee due to some reasons, they are also considered to participate in the admission process, subject to the condition that they will pay the requisite registration fee to the concerned training institute at the time of confirmation of their admission and also ensure compliance of other instructions related to admission process . List of candidates is Annexed at B.
- 4. Eligible candidates whose names are appearing in the National List of eligible candidates are advised to report to any of the Training Institutes as per their choice of course and institutes mentioned in the application form along with the requisite original documents to participate in the admission process within the stipulated time period. Instructions for the candidates to participate in admission process is Annexed at C.
- Training Institutes are advised to start the admission process with due verification of class  $10^{th}~\&~12^{th}$  marksheets and other requisite documents of the candidates through Admission Committee and display the merit list of candidates on their website as well as on the Notice Board for information to all the concerned. Detailed admission guidelines and schedule for admission for Training Institutes is Annexed at D.

- 6. On completion of admission process, training institutes shall submit the list of admitted candidates to the NBER, RCI, on the prescribed format.
- 7. All the Heads of the approved Training Institutes as well as eligible candidates are advised to carefully go through the instructions and admission guidelines for strict compliance. Any kind of violation/deviations in this regard by the training institutes or the candidates may result in cancellation of admission and suitable action as deemed fit.
- 8. Training institutes shall not admit candidates without valid Centralized Online Application Number. List of such candidates shall not be considered by the NBER, RCI under any circumstances. Therefore, Training Institutes are advised **Not To** violate the prescribed norms.
